

# 2008 Auctioneer Fall Seminar Free CES Designation Course

The OAA is offering this 3 day designation course in Certified Estate Specialist (CES) at no charge. This is a \$600 value per person. Attendees will learn to market their services to professionals (CPA's, trustees, tax attorneys, financial planners, etc.) who deal with estates. This course covers legal and financial aspects, duties, the relationship of parties involved in an estate, role of the auctioneer, and how to position your firm to take advantage of the opportunity. You must attend all three days, complete and pass a test on the last day to receive the designation. In order to keep the designation active, you will be required to renew with the NAA at a fee of \$50.00 annually. You must also complete 24 hours of CE every three years. The OAA will submit this course to the Division of Real Estate for continuing education credits in Ohio real estate. The amount of CE's will be determined based on the course outline, at a later date.
