Welcome to the first edition of Century Notes, a newsletter for Ohio's century farm owners.


This edition and future editions will help keep you informed about upcoming events and news regarding Ohio's century farms.



A Brief History: Ohio's Century Farm Program

The Outstanding Ohio Century Farm program began in 1993, with families competing to be named as the outstanding farm of the year. With so many deserving applicants, the decision was made in 2003 to honor each qualifying century farm. As a result of this change, there are now more than 850 farms registered as Ohio Century Farms.

Century Farms Now in 85 of Ohio's 88 Counties

With more than 850 farms registered across the state, it would be a logical assumption that each county has at least one farm registered as a Century Farm at the Ohio Department of Agriculture. In actuality, there are three counties - Athens, Noble and Pike - not yet represented.

Many people who contact the department about the program indicate they didn't know the Ohio Century Farm Program existed until they saw their neighbor's yard sign or read an article in their local paper. With limited staffing, the problem is how to reach out across the state to raise awareness about the program.

Local partner networks have formed, and are forming, with



historical groups, Soil and Water Conservation districts, Farm Bureau offices, Extension offices and county recorders across the state. The partners help identify potential farms, encourage interest, assist with applications, celebrate with the recipient, and inform the office if any ownership changes occur to the registered farms.

Materials available to program partners include a tabletop display, brochures, and the loan of exhibit panels formerly used at the State Fair and Farm Science Review.

Upcoming Century Farm Landmarks

- The Century Farm program is closing in on 1,000 registered farms. We currently stand at just under 900. Typically 50-60 new farms are registered each year.
- Registered century farms are located in 85 counties; we need Athens, Noble and Pike registrations in order to hit all of Ohio's 88 counties.

Ohio's Bicentennial Farms

Perserverance is a term that applies to all Century Farm families. It's amazing to think that a single family has witnessed all the joys and endured all the struggles on that same farm for 100 years.

Even more mind-boggling is when a family has owned the same farm since before Ohio became a state, even before the nation achieved independence. And that is the case with Ohio's oldest registered farm, which dates back to 1772 and is located in Adams County.


Many of the registered Ohio Century Farms qualify as bicentennial farms, remaining in the same family for at least 200 years. While these farms are known to belong to that special bicentennial category, they have never been formally recognized as such by the department. A Bicentennial Farm program is under consideration. Farms currently registered in the Ohio Century Farm program would be eligible for this recognition; no additional registration would be required.

Century Farm Signs Available

Century Farm signs are available for purchase on an on-going basis exclusively to all Ohio century farm owners. Since 2005, more than 300 signs have been ordered for distribution across the state.

Signs are made of aluminum, measure 24" x 20.25" (or 30" x 20.25" with an optional nameplate), and are produced by the Scioto Sign Company. All orders are processed through the Ohio Department of Agriculture to ensure that only century farm families have access.
