MISSION STATEMENT

The Partnership is an advocate for effective collaboration in rural development through private-public and intergovernmental cooperation to enhance the quality of life for rural Ohioans.

INTRODUCTION

The Ohio Rural Development Partnership (ORDP) is a statewide organization which brings together citizens, community based organizations, representatives of the private sector, and federal/state/local government officials to collectively address the needs of rural Ohio communities.

ORDP provides the forum for members of the agriculture industry, health care industry, educational institutions, economic and community development organizations, for-profit and non-profit corporations, and social service agencies to cross traditional boundaries, share information, and address the special needs and opportunities in rural Ohio.

COMMITTEE STRUCTURE

The strength of the Partnership is founded on the strength of its membership and committees. The Partnership database includes nearly 700 people who have indicated their concern for Ohio and their interest in Partnership efforts. Each member brings a unique perspective, background, knowledge, and skill base to the table.

STANDING COMMITTEES

In addition to the Executive Committee and the Steering Committee, the ORDP has four Standing Committees which are responsible for the overall management and direction of the Partnership efforts:

- Budget and Administration Committee
- Communications Committee
- Nominating & Membership Committee
- Strategic Planning Committee

ACTION COMMITTEES

Three Action Committees address specific areas of rural development. Each committee identifies significant issues of concern and develops strategies aimed at overcoming barriers and capitalizing on opportunities.

- Agriculture Committee
- Community and Economic Development Committee
- Health Committee (Ohio Rural Health Coalition)

ACTION PLAN STRUCTURE

ORDP's Action Plan has been organized into four sections. The first section addresses the administrative functions of the ORDP and focuses on those activities which will be carried out primarily by the Executive Director and the Executive Secretary (position currently vacant) with guidance provided by the Steering Committee.

The next three sections outline the goals, objectives, and action steps of the three Action Committees.

CORE DESCRIPTION: Steering Committee

Problem Statement

As the governing body of the Ohio Rural Development Partnership, the members of the Steering Committee are responsible for determining the activities of the Ohio Rural Development Partnership. Ensuring the viability of the partnership includes increasing the awareness and visibility of Partnership efforts, supporting the Issue Committees, collaborating with Ohio's Small Communities Environmental Infrastructure Group and the Ohio Economic Development Association, and providing the necessary resources to support the administrative functions of the Executive Director and support staff.

CORE DESCRIPTION

PROBLEM STATEMENT

As a result of the Ohio's first Rural Policy Summit that was held in December 2003, several issues relating to Ohio agriculture were identified. The priority issues included:

4. *Participate in the Ohio Farm Bureau Annual Meeting.*

COMPONENT #2: Access to Capital and Business Expansion in Rural Ohio Communities

CORE DESCRIPTION

PROBLEM STATEMENT

In many rural areas of the state, awareness of and access to federal and state financing programs for small businesses is limited. Many community-based banks and lending institutions are not taking full advantage of state and federal programs like SBA, linked deposits, and revolving loan fund programs. In addition, many small and developing businesses are unaware of these programs for potential financing.

GOAL(S) AND OBJECTIVES

1. *Better understand the barriers community based banks and business have utilizing federal and state programs and develop ways to address, minimize, and/or eliminate these barriers.*
2. *Increase access to capital by small businesses in rural Ohio by increasing awareness and knowledge of the capital funding sources available and thereby increase utilization of these capital sources.*

Lack of access to high quality and adequate health care services in rural communities continues to be a challenge. Many rural areas in the State of Ohio experience shortages of primary care, mental health, and dental providers.

1. *Educate state policy makers, rural community leaders, rural health care providers, and others on policies, program, and activities to strengthen the rural health care system.*
2. *Continue to grow and develop the Ohio Rural Health Coalition*

Profitability of Agriculture:

- ✓ Low commodity prices and weather disasters have negatively impacted Ohio producers for several years.

Urban Development, Land Use:

- ✓ Prime agricultural land continues to disappear.
- ✓ The rural urban transition zone is less defined and more contentious.

Livestock Production Controversy:

- ✓ Livestock permitting/siting is becoming more contentious.
- ✓ Technology, economies of scale and low margins are driving livestock producers to grow.
- ✓ Rural residents and urban transplants are less accepting of livestock farms.
- ✓ Livestock production is still important to the agricultural and local economies.

Drainage:

- ✓ Non agricultural neighbors, environmental issues and public oversight/control has complicated drainage solutions and outdated some of the drainage laws.

Health Care:

- ✓ Agricultural producers and other self-employed persons have difficulty accessing affordable health care insurance.
- ✓ Quality of Emergency Medical Response is declining in some rural areas.

Wildlife Damage:

- ✓ Wildlife populations continue to escalate with fewer hunters/trappers and greater protections by wildlife agencies.
- ✓ Car/wildlife collisions continue to escalate resulting in millions of dollars in damages and ever-greater injuries and deaths.
- ✓ Neighbors and the public are challenging wildlife control methods.

Trespassing:

- ✓ ATV, snowmobile and other recreational vehicle operators often do not respect private property.
- ✓ Vandalism, littering and property owner liability issues are increasing.

Zoning:

- ✓ Lack of zoning in many rural areas.
- ✓ Zoning poorly enforced in some rural areas.

Regulatory Burden:

- ✓ Environmental, Labor, Health Department, zoning, bioterrorism, safety, transportation and other regulations and reporting requirements are overwhelming farmers and small businesses.
- ✓ Direct Marketers have recently been the target of numerous licensing, inspections, reporting and packaging requirements and product restrictions.

School Funding (K-12):

- ✓ Rural schools in general receive fewer dollars per student and local property owners have a high tax burden.

Rural Development Policy:

- ✓ Lack of statewide rural development policy, a plan, and a coordinating agency.

Equity Capital:

- ✓ Equity capital gap exists for small businesses and start-ups.

Entrepreneurship Assistance:

- ✓ Need for more coordinated and accessible entrepreneurship assistance.

Broadband/Technology:

- ✓ Need to improve access to broadband and other technology.

Response to Growth:

- ✓ Increasing unplanned growth and lack of local and regional comprehensive planning capacity.

Funding Project Planning:

- ✓ Many grant programs too limited in allowing funding for administration, preliminary planning, and engineering costs.

Groundwater Contamination & Wastewater treatment:

- ✓ Resources are limited to address wastewater treatment and groundwater contamination needs.

Workforce Training:

- ✓ Existing business dissatisfied with skills/education level of workforce.

Youth Retention:

- ✓ Rural communities need to retain our youth (stop “brain drain”).

Transportation/Infrastructure:

- ✓ Rural communities lack capacity to maintain/improve transportation infrastructure improvements on their own.

Leadership Capacity:

- ✓ Rural communities lack sufficient leadership and leadership development capacity.

Emergency Services & Emergency Preparedness:

- ✓ Rural communities have limited emergency services and emergency planning capacity.

Higher Wage Jobs:

- ✓ Rural communities need to attract higher paying service and industrial jobs.

HEALTH ISSUES

Overall Rural Health Policy:

- ✓ Ohio does not have a statewide rural health policy.

Health Care and Local Economies:

- ✓ Economic development activities and opportunities often exclude or fail to recognize health care as a significant contributor to rural economies.

Broad Community Support of Rural Health Care:

- ✓ Rural health care planning and decisions often do not engage the broader community, resulting in lost local awareness and support.

Emergency Services and Transport:

- ✓ Non-emergent transportation not available in some areas, limited availability in others, resulting in inappropriate use of EMS, and overuse of volunteer EMS.
- ✓ Current and proposed trauma care systems negatively impact rural systems and access.
- ✓ Rural EMS is under-funded, under-staffed, under-equipped and under-trained.

Individual empowerment:

- ✓ Rural residents, especially those with chronic diseases and conditions, lack care options, resources and information to adequately care for their own health.
- ✓ Rural residents feel their needs are not heard or addressed by many providers.

Inadequate access to an array of health care services:

- ✓ There is a shortage of health care professionals in rural Ohio.

Rural Health network development:

- ✓ Scarce resources and market challenges increase the need for provider organizations to collaborate, instead of duplicate.

Aging Population:

- ✓ Rural health systems are seeing fewer children (less Medicaid) and more adults and elderly who are uninsured/underinsured.
