J&J Snack Foods Issues a Nationwide Recall of their Expired Frozen Peanut Butter Cookie Dough

Pennsauken, NJ - J&J Snack Foods Sales Corp, Pennsauken, NJ announces that due to the expansion of Peanut Corporation of America's Salmonella recall, they are initiating a voluntary nation-wide recall of **expired** raw, frozen, peanut butter cookie dough distributed to Food Service and Fundraiser customers because of possible health risks.

Salmonella is an organism, which can cause serious and sometimes fatal infections in young children, frail or elderly people, and others with weakened immune systems. Healthy persons infected with Salmonella often experience fever, diarrhea, nausea vomiting and abdominal pain.
