**Tom Paige Catering Company Issues Consumer Alert and Recall on Product
Contaminated with *Listeria monocytogenes***

Cleveland (Feb. 9, 2010) – Tom Paige Catering Company of Cleveland, Ohio today issues a public notice and recall to alert consumers about product contaminated with *Listeria monocytogenes*. The contaminated product was discovered from a sampling of chicken and dumplings during routine meat inspection services provided by the Ohio Department of Agriculture. To date, no illnesses have been reported.

Due to the presence of *Listeria monocytogenes*, all products received from Tom Paige Catering on or after Feb. 2, 2010, should be returned to the company, excluding any frozen three-compartment meals. Consumers who have received the frozen three-compartment meals should follow cooking instructions listed on the product label.

According to the Centers for Disease Control and Prevention, listeriosis is a serious infection caused by eating food contaminated with the bacterium *Listeria monocytogenes*. The disease affects primarily persons of advanced age, pregnant women, newborns and adults with weakened immune systems. However, persons without these risk factors can also be affected. A person with listeriosis may develop fever, muscle aches and gastrointestinal symptoms such as nausea or diarrhea. If infection spreads to the nervous system, symptoms such as headache, stiff neck, confusion, and loss of balance or convulsions can also occur.

If products from Tom Paige Catering Company were consumed, and any symptoms of illness develop, the consumer should consult a physician.
