FURTHER EXPANDED Recall Period of Certain Sunflower Kernel Products Due to Possible Contamination by *Listeria monocytogenes*

June 1, 2016 - TORONTO – Acting out of an abundance of caution, SunOpta has decided to further expand its voluntary recall of certain sunflower kernel products due to the potential to be contaminated with *Listeria monocytogenes*, an organism which can cause serious and sometimes fatal infections in young children, frail or elderly people, and others with weakened immune systems. Although healthy individuals may suffer only short-term symptoms such as high fever, severe headache, stiffness, nausea, abdominal pain and diarrhea, listeria infection can cause miscarriages and stillbirths among pregnant women.

This further expanded recall includes certain sunflower kernel products originating from SunOpta's facility in Crookston, Minn. between May 31, 2015 and January 31, 2016. No illnesses related to the consumption of these products have been confirmed.

Recalled retail sunflower kernel items were sold in clear printed plastic packages and are marked with Best By Dates located on the front or back of the packages. Recalled snack bars were sold in boxes of 12 units. Listed below are details regarding the recalled items:
